

CONSULATE OF FINLAND UPDATES:

The new Finnish biometric passport system went into effect on August 21st 2006. Passports issued before the introduction of the new system will remain valid until their expiration date. New biometric passports are valid only five years.

Honorary Consulates no longer handle passport applications. Please contact Consulate Generals in New York tel. 1-212-750-4400 or Los Angeles tel. 1-310-203-9903 or Embassy of Finland in Washington D.C. tel. 1-202-298-5800 regarding the new passports.

Deadline for Finnish Citizenship Declarations (so called dual citizenship) will be 31st of May 2008. ONLY 18 months to obtain your Finnish Citizenship by declaration.
